### TIPS Releases 2026 – TIPS R2026.NOV provisional scope (2/2)

- Recently, it has been proposed to tentatively allocate the TIPS-0075 into the R2026.NOV scope.
- At the current juncture, given the lack of stability for 5 out of 10 CR detailed assessments included in the provisional scope, it is not possible to provide a reliable 4CB feasibility assessment for 2026 November release.
- The exercise shall be repeated once again after the completion of the related missing Detailed Assessments.
